

CONTROL COMMITTEE PUBLICATION

OWNER	Thomas Burke
ADDRESS	Carnaseer, Dunmore, Co. Galway
MATTER	Presenting the greyhound Winter Dream for racing at Galway Greyhound Stadium on the 20 th of June, 2014 with the prohibited substance Propranolol.
OUTCOME	The Control Committee took a very serious view of this matter and was satisfied Proranolol was a substance of particular significance. The Committee noted Mr. Burke did not engage with the Committee and imposed a fine of €750 on Mr. Burke. The Committee also directed that all greyhounds in the ownership or under the care of Mr. Burke be subjected to sampling when presented for racing for a period of four months. (No prize money won).

OWNER	Paula Cullen
ADDRESS	7 Victoria Road, Dungannon, Co. Tyrone.
MATTER	Presenting the greyhound Baltovin Billy for racing at Dundalk Greyhound Stadium on the 14 th of November, 2014 with the prohibited substance Cyclizine.
OUTCOME	The Control Committee noted that the substance Cyclizine was a very serious substance and given the limited co-operation from Ms. Cullen, the Committee decided to impose a fine of €1,500 on Ms. Cullen. The Committee also directed that all greyhounds in the ownership or under the care of Ms. Cullen be subjected to sampling when presented for racing for a period of six months. (No prize money won).

ADDRESS	48 Drumrallagh, Strabane, Co. Tyrone
MATTER	Presenting the greyhound Paddock Paula for racing at Lifford Greyhound Stadium on the 6 th of December, 2014 with the prohibited substance Amphetamine.
OUTCOME	The Control Committee noted that the detection of the substance Amphetamine in a sample obtained from a greyhound was a very serious offence and imposed a fine of €1,000 on Mr. Friel. (No prize money won).

ADDRESS	262 Killinarden Estate, Tallaght, Dublin 24
MATTER	Presenting the greyhound Daylens Rocket for racing at Harolds Cross Greyhound Stadium on the 5 th of May, 2015 with the prohibited substance Heptaminol.
OUTCOME	The Control Committee considered all of the evidence tendered including details of Mr. Hamilton's previous offences. In the circumstances and having regard to the nature of the substance Heptaminol, the Committee imposed a fine of €500 on Mr. Hamilton and forfeiture of €95 prize money.

MATTER	Presenting the greyhound Tromora Molly for a Sales Trial at Limerick Greyhound Stadium on the 19 th of May, 2015 with the prohibited substance Dexamethasone.
OUTCOME	The nature of the substance Dexamethasone was noted and the minimum fine of €100 was imposed on Mr. Hogan.

MATTER	Presenting the greyhound Stephanies Glory for racing at Lifford Greyhound Stadium on the 11 th of July, 2015 with the prohibited substance Caffeine.
OUTCOME	The nature of the substance Caffeine was noted and the minimum fine of €100 was imposed on Ms. O'Hanlon. €15 prize money was forfeited.

MATTER	Presenting the greyhound Fairyhill Josie for a Sales Trial at Thurles Greyhound Stadium on the 23 rd of June, 2015 with the prohibited substance Meloxicam.
OUTCOME	The nature of the substance Meloxicam was noted and the minimum fine of €100 was imposed on Mr. Rafferty.

MATTER	Presenting the greyhound Loughlea Pretty for a Sales Trial at Thurles Greyhound Stadium on the 23 rd of June, 2015 with the prohibited substance Flunixin.
OUTCOME	The nature of the substance Flunixin was noted and the minimum fine of €100 was imposed on Mrs. Treacy.

OUTCOME	The nature of the substance Caffeine was noted and the minimum fine of €100 was imposed on the registered owners. (No prize money won).
